4. Criteria and Procedures for Nomination of Directors

As for the existing directors, the Nomination, Remuneration and Corporate Governance Committee considered the past performance as the independent directors, the directors, and the members of sub-committee. The nomination procedures are as follows:

- (1) The Company provides an opportunity to shareholders to nominate qualified candidate(s) for the directorship during August 31 November 30, 2018.
- (2) The Nomination, Remuneration and Corporate Governance Committee considers the candidates nominated by shareholders and recommends the Board to propose to the Annual General Meeting of Shareholders to elect the qualified candidates to be directors.
