

Warranty Policy

For LED Underwater Fishing Light - BlueFin

This document sets forth the warranty policy of the LeKise International Sales Organization (“LeKise”) from which you (“Purchaser”) purchase your LED Underwater Fishing Light. This policy is applicable only to LeKise branded LED Underwater Fishing Light (“Products”) purchased as from 1 February 2015 used on Fishing Boats with power supply rated for AC100V, AC220V, DC12V or DC24V ONLY.

This warranty policy is subject to the provisions as set forth herein and is subject to the terms and conditions as attached to this document (‘Warranty Terms and Conditions’).

This warranty policy only applies if referred to in a sales contract between LeKise and the Purchaser and it will replace the standard warranty clause provided in the LeKise Lighting general terms and conditions of sale.

A. Warranty Period

Subject to the provisions as set forth in the Warranty Terms and Conditions and as set forth hereunder, Purchaser receives the warranty for the applicable period, as described in table 1 hereunder.

B. Special Conditions

- The warranty period starts on the date of invoice.
- The warranty period is based on a usage behavior of maximum 4500 hours/year with maximum of 5 switching per day.
- **Operating conditions are strictly followed:**
 - **BlueFin™ MUST NOT, in any case, to be operated above water; AND**
 - **BlueFin™ MUST be fitted with optional marine grade power cable with a minimum size of 11AWG, 2 core, cross section 4mm², outer diameter Φ 13mm; AND**
 - **BlueFin™ – Unit is submerged into the water (within the depth range based on the product model specifications) BEFORE the unit is powered on; AND**
 - **Power to the lamp MUST be switched off BEFORE lifting the lamp out from the water; AND**
 - **The lamp can be lifted AFTER power shut down for 10 min; AND**
 - **Water temperature to be < 26°C**
- This warranty is VOID if the Purchaser fails to comply with the LeKise operational specifications and installation instructions or subjecting this product to abnormal use or stress, which includes under/over voltage conditions, excessive switching cycles, operating temperature range and/or IP rating exceeding the specified operating range.
- This warranty is VOID if this product is found modified or attempt to modify from its designed specification.
- LeKise shall not be responsible for any failure of this product as the result of external causes, including but not limited to, acts of God, power surges that exceeds product specification, improper power supply, improper or unauthorized use; failure of the Purchaser or user(s) to effectively handle, install, maintain, service and operate this product or any other causes other than defect in material or workmanship of the product.
- This warranty is VOID if this product have been serviced by non-authorized personnel.
- In any case of product warranty claims, the warranty period of the replacement unit will be adjusted to the remaining balance of the original product warranty period.
- LeKise reserves the right to replace with comparable product if this product model have been discontinued or not available.
- Purchaser shall not rely upon any other information or documentation.
- **PRODUCT REPLACEMENT/REPAIR IS LIMITED TO THIS LIMITED WARRANTY TERMS AND LEKISE SHALL NOT BE LIABLE FOR ANY DAMAGE OR LOSS OF PROFIT FOR THE UNAVAILABILITY OF THIS PRODUCT DURING ANY DURATION OF THIS WARRANTY PERIOD.**

Power Supply Unit

- Ensure proper ventilation and no blockage to the vents for BlueFin™ Fishing Light system power supply to prevent over-heating.
- Danger - high voltage and current. Do not open the power supply case. Repairs should only be done by LeKise.
- Do not modify the voltage or current from the product specification. LeKise shall not be responsible for any damages caused by unauthorized modification.

This warranty only covers Products applied within their 'intended' or 'normal use' as defined by:

- Operating conditions are in accordance with the information on the products and its packaging; AND
- Ambient temperature never exceeds the operating temperature range -20 °C to +40 °C; AND
- Product is NOT subjected to ON/OFF switching faster than 3min interval; AND
- The electrical installation in which the product operates is not subjected to voltage fluctuations in a range exceeding +/- 10% volts.

C. Summary Warranty Terms and Conditions (non-exhaustive)

- This warranty policy is valid only for products sold with marine vessel power supply rated for AC100V, AC220V, DC12V or DC24V ONLY.(refer to model voltage).
- Rubber and sealing parts are excluded.
- Lower/lift the lamp away from the ship board to prevent collision damage.
- Unit to be inspected before and after use for any damage. Any damage needs to be repaired before using.
- Check and remove any foreign objects found entangle to the lamp.
- Products have been purchased directly from LeKise or its authorized distributor.
- Proof of purchase is available for inspection by LeKise or its authorized distributor.
- Products have been properly installed and operated in accordance with the manufacturer's instructions.
- Adequate records of operating history are available for inspection by LeKise or its authorized distributor.
- A LeKise representative will have access to the defective Products. If the Products or other parts become suspect, the representative shall have the right to invite other manufacturers' representatives to evaluate the lighting systems.
- Labor costs for (de-)installation of the Products are not covered under this warranty.
- Defective product(s) to claim under warranty must be shipped back to LeKise, and shipping costs shall be borne by Purchaser.
- Shipping costs back for repaired / replacement lamp under this warranty conditions shall be covered by LeKise.
